Delegation of Authority (Interim) - Approval of Exceptions to Approved Indirect Cost Rates

Effective as of the date above, I hereby delegate to your positions, in your areas of responsibility, the authority to approve the application of an indirect cost rate other than the approved indirect cost rate as determined in accordance with 2 CFR 220 (formerly OMB Circular A21) for submission and acceptance of contract and grants under which UCLA conducts programs supported by extramural funds, other than those provided by the federal government. Any such application of an indirect cost other than the approved rate shall be in accordance with existing policy and practice, including guidance in the University of California Contract and Grant Manual.

Exercise of this authority is subject to the limitations set forth in the matrix below.
